# **Approval of Minutes**

Council Member Doll moved to approve the minutes of the November 16 General Meeting and the November 23 and 30, 2021 Executives Sessions. The motion was seconded by Vice President Kauffman and passed. Council Member Budreau abstained from voting on the November 23 and November 30 Executive Sessions.

## **Employee Reports**

· Chief Tom Baker

Everything went well with the Christmas parade and he expressed thanks to SJC Police, VEST and the County Reserves for their assistance. He reported that most people complied with the no parking on Michigan Street during the parade. Chief Baker has been on vacation and so asked Assistant Chief Croymans to present the following report: 196 Calls for Service; 10 Criminal Investigations; 5 Criminal Cases from the prior month were closed due to investigations including 2 felony cases and 3 misdemeanor cases. The special interest program resulted in \$35,343 recovered, 3 arrests (1 gun, 1 drug and 1 warrant) and the Traffic Calming Device in the 200 block of E Front recorded 786 cars with 0 speeders and a high speed of 23 mph during the time it was in place.

• Jason Quirk, Electric Department

Rescheduled the tree trimming for week of January 4 through  $7^{\rm th}$  due to schedule conflict. The Alley behind the FD will be closed Thursday through Monday as part of the structure improvement project. He recently participated in a discussion on purchased power and said that the Town looks great with everyone chipping in.

• Engineer Jared Huss

We are closing out the sidewalk improvement and street restoration projects.

They are completing estimates on the Meridian Street Project for next year's CCMG Application.

He has been in contact with Cleveland Cliffs and is waiting on a response to set a meeting to discuss the assessment prepared for them.

He is working on sanitary estimates for Perry for budgeting next year

SJEC received the final bill for the wellhead study and they are paying for all of that.

Has been working with Robert on fire pump and other items

The will have a spray pad meeting on Thursday so that we can get renderings to the Laureys family as soon as possible.

• Attorney Andrea Halpin

Has attended several meetings and drafted and modified ordinances.

Vice President Kauffman moved to accept the quote from Axon for recording equipment for the evidence room at a cost of \$21,540.98. Seconded by Council Member Budreau the motion carried 4 -0.
