

**New Carlisle Town Council**

The Public Hearing was opened with the Pledge of Allegiance.

President Higgins called the public hearing to order with Vice President Vojtko, Council Member Gelow, Council Member Carter, Council Member Rypma and Clerk-Treasurer Sue Moffitt present.

Council Member Rypma moved to waive the rules to read Ordinances #1310 and #1311 by caption only for the second reading. The motion was seconded by Council Member Gelow and passed unanimously.

President Higgins opened the floor to Eric Walsh of Umbaugh.

Eric reports that the two ordinances read tonight include electric and sewer rates. The electric ordinance will effect those that have private security lights and also street lighting rates paid by the town to the electric department.

Eric reports that the sewer ordinance is twofold. As the Town sends sewage to the City of South Bend, we have had several increases that have not been passed along to residents and have, instead, been absorbed by the Town. Through the tracking factor portion of this ordinance, the cost of rate increases will be passed on to residents. The second portion is a rate increase. Approximately half of the total increase is attributable to direct increases in South Bend rates and the other half due to no sewer rate increases since 2007.

This being the public hearing for Ordinances #1310 and #1311, President Higgins opened the floor to public comment and questions.
